





At approximately 10:30 p.m. a scene showing two men in a bathroom stall engaged in open mouthed kissing, kissing on the neck and partially undressing each other where one male appeared to move his head downwards out of the camera's view. The scene was not apparently relevant to the story line i.e. removing it would not have left any lack in the plot. The scene was based on rekindling a previous one night stand as alluded to in a conversation between the two men. 
