While watching Desperate Housewives, the use of the word Bitch was used several times in describing characters and was used during a commercial advertisement for another show this week.

The "B" word was also used during the March 21 airing of Modern Family. In which a character refers to another real estate agency as a Bitch. While we have chosen not to have our children watch these shows with such language, allowing bitch to be used during commercial advertisements does not provide us with the opportunity for prescreening.

Furthermore, ABC has a new series that insinuates use of the "b" word. The "B@#^C in Apt" something is another show that seems to want this word to be common and acceptable language. As a parent, I'm finding that network television is following suit of cable television with the increased use of - in my opinion - inappropriate language during commercials and during television shows.
